RESORT CHARGES

TAXES, LEVIES, and FEES - Royal, Coral, Beach, Cove, and Reef

Taxes: 10.0% VAT (Value Added Tax) assessed on all charges, except gratuities

- The VAT rate is subject to change depending on the rate applicable at the time the services are rendered.

Resort Levies: 11.0% Tax (PITDA and NPIP) assessed on nightly room rate

- Paradise Island Tourism Development Association & Nassau/Paradise Island Promotional Board

Resort Fee: \$30.00 plus VAT per room per night (Royal), \$35.00 plus VAT per room per night (Cove)

GRATUITIES

Bellman: \$6.00 per person, one-time charge, 12 years old and over

Pool/Beach Attendant/Lifeguard: \$1.60 per person, per night, 12 years old and over

Housekeeping – Royal \$5.00 per person, per night, 12 years old and over

Housekeeping – Cove: \$6.00 per person, per night, 12 years old and over

MAXIMUM OCCUPANCY AND ADDITIONAL COST PER PERSON

Royal - Room rates are quoted based on single or double occupancy. Additional occupants 12 years old and over will be charged at a rate of \$50.00 per person, per night, plus applicable Resort Charges, with a maximum of four (4) persons per guest room allowed.

Cove - Room rates are quoted based on single or double occupancy. Additional occupants over double occupancy will be charged at a rate of \$75.00 for guests 18 years and older and \$50.00 for guests 12–17 years old. Extra charges are per person, per night, plus applicable Resort Charges. Maximum number of adults (18+) is four (4) in the Ocean, Deluxe Ocean, Club Deluxe Ocean and Indigo suites. A fifth person is allowed if four (4) years of age and under. Maximum occupancy in the One-Bedroom Sapphire Suite is three (3); two (2) adults and one (1) child under 12. To check-in at The Cove, at least one guest must be 21 years of age and present a valid credit card in their name.

The above charges are mandatory pursuant to applicable union contracts, will be automatically added to the final bills of the Group or individual attendees as applicable (provided, however, the Group agrees to pay such charges not otherwise paid by individual attendees) and are subject to change at any time upon notice to the Group.
